Surat Customs dept to start attaching Nirav Modi's assets

A warrant under CrPC section 70 was issued against Nirav Modi on June 22.

THE SURAT customs department will begin the process of attaching properties of fugitive diamond merchant Nirav Modi, after he failed to appear before Surat district Chief Judicial Magistrate Court, on Thursday, which was the deadline prescribed while declaring him absconder under CrPC Section 82.

The court had on October 10 acted on the application of the Surat Customs department, and declared Nirav Modi as an absconder under CrPC Section 82. In the court's order, it was mentioned that Modi should remain present in the court on November 15.

Sources said that as per the legal provisions, the Surat Customs department officials will soon submit an application before the Surat district Chief Judicial Magistrate Court to seek permission to attach his properties. If the court permits, the Customs department will identify his properties in Surat and in other parts of the country as well and start attaching them.

The Customs department in Surat had registered an offence against Modi and his firms - Firestar Diamond International Pvt Ltd, Firestar International Pvt Ltd, Radhasir Jewellery co pvt.

Ltd - under sections of 135 (1) (A)(I), section 135(1), (B)(I), 132 and section 140 of Customs Act 1962. An arrest warrant order dated June 22, 2018 under section 70 of CrPC was also issued against him.

DRI officials in Mumbai had seized export consignments of three diamond and jewellery firms of Modi from Surat Hira Bourse in Mumbai on December 5, 2014. The three firms of Modi through which exports were shown are Firestar International Diamonds Limited, Firestar International Private Ltd and Radhasir Jewellery, all located at Special Economic Zone (SEZ) at Sachin in Surat.

Modi had violated the norms of SEZ by selling the imported high-quality polished diamonds in the local domestic market and had exported low-quality diamonds-studded gold jewellery.

MONK 'MOLESTED' Surat court grants bail to accused

THE 21-YEAR-OLD youth, who was arrested on Tuesday for allegedly attempting to molest a female monk, was granted bail by a court Wednesday after his police remand application was rejected.

The accused, Akshay Rathod, was produced before the court by Athwalines police for obtaining his five-day remand.

Meanwhile, police said that the monk's statements under CrPC Section 164 will be recorded soon before a judicial magistrate.

After taking consent of the court, Athwalines police contacted Ashit Gandhi, a follower of the monk, and told him that he should make her ready to record her statements. Gandhi had registered the molestation complaint with Athwalines police station on behalf of the monk.

Police inspector H B Bharwad said, "We have submitted an application before the Surat district court in connection with recording the statements of the female monk under CrPC Section 164. The court will give us time and our female police officers will accompany the monk to the court to get her statements recorded."

Surat police had on Tuesday night arrested Rathod, a diamond polisher and the son of a Jain temple priest's helper, for allegedly entering the Upashray (resting place of Jain monks) and touching the monk's feet.

A YEAR AFTER BJP LEADER 'KILLED SELF'

Police arrest two, book them for abetment to suicide

VADODARA, NOVEMBER 15

A YEAR after a BJP leader allegedly committed suicide in Karjan taluka of Vadodara, the Karjan police on Wednesday night arrested two persons and booked them for abetting his suicide.

Pinakin Patel, a former president of BJP Yuva Morcha, had allegedly committed suicide in October last year. Patel had reportedly taken the extreme step after he had borrowed money from some people at high interest rates and was unable to repay it.

According to the police, they had recovered a personal diary of Patel and based on the entries in the diary, the arrests were made.

The two arrested are Praveen Singh Ataliya, a BJP worker from Karjan, and Bharat Singh Chavda, the current Congress president of Karjan taluka. According to the police, in April last year, a case of accidental death was registered and the investigation into the case was eventually handed over to the Local Crime Branch (LCB), Vadodara rural.

Police said that the personal diary of Patel had entries only till May 2017. "We had not recovered any suicide note but we found the diary based on which the arrests have been made. The diary had stated that Ataliya and Chavda had lent money to

Pinakin. We are yet to investigate about how much money they had lent him and if they had pressured him to return the money. No other names have come to the forefront yet," said police inspector Ajay Gadhvi, who is the investigating officer in the case.

Patel, a resident of Manjalpur, had gone to visit his parents' house at Kantharia in Karjan where he allegedly took the extreme step when he was alone in the house. As per the police, Patel's parents were not at home when he arrived and he had taken the keys from the neighbours to open the house. When his parents had tried calling him repeatedly that afternoon, his phone was switched off. They had then asked their neighbours to break open the door, who had found Patel hanging from the ceiling fan.
